## RESPONSE TO QUESTION ON NOTICE Questions on Notice Paper No 4 21 March 2025 Question No. 239

MS MORRIS: To ask the Minister for the Prevention of Family and Domestic Violence —

- 1. Given that the number of domestic violence related assaults reported per annum across the Brindabella Electorate since 2018 were (a) 2018 308, (b) 2019 299, (c) 2020 329, (d) 2021 286, (e) 2022 314, (f) 2023 326 and (g) 2024 to June 150, how many domestic violence related assaults have been reported per annum across the Brindabella Electorate in (i) 2024 and (ii) 2025 to date.
- 2. Of the reports referred to in parts (1), how many have led to the prosecution of the perpetrator.
- 3. What actions are being taken to reduce the number of domestic violence related assaults.



3) ACT Policing operates on an evidence-led, pro-charge, pro-arrest and presumption against bail policy for domestic and family violence (DFV) incidents. ACT Policing also follows a pro-intervention policy when there is insufficient evidence to commence judicial proceedings and recognises the importance of community-led solutions to support and prevent further harm to victim survivors of family violence.

ACT Policing works collaboratively with agencies and stakeholders throughout the domestic and family violence sector. The majority of responses to and investigation of DFV incidents in the ACT is carried out by frontline uniform patrol officers across the five ACT Policing stations.

On 28 June 2024, the creation of a new Domestic and Family Violence Investigation Unit (DFVIU) was announced. This is an expansion and restructure of ACT Policing's existing Family Violence Unit (FVU) which was primarily focused on coordination.

ACT Policing's DFVIU leads domestic and family violence training and quality assurance, as well as ensuring a consistent response to domestic and family violence incidents.

DFVIU targets high-risk perpetrators and works closely with the Family Violence Safety Action Program (FVSAP) in target development and whole-of-sector approaches to ensure victim-survivor safety and perpetrators are being held accountable.

In response to our jurisdictional priority of addressing coercive control, the DFVIU has reviewed and facilitated police family violence refresher training, working with partner agencies Domestic Violence Crisis Service (DVCS), Children Youth and Families (CYF, formerly CYPS) and Canberra Rape Crisis Centre (CRCC).

To ensure the continuing success of the DFVIU in supporting ACT Policing members and the broader community, DFVIU has completed work to generate and implement system level change by modernising case tracking, adjusting the way police engage with the courts and improving the way FVOs are served and managed for persons in custody.

ACT Policing have adopted the use of the Family Violence Risk Assessment Tool (FVRAT) to assess the risk of future family violence that a person poses towards another person, and is mandatorily completed for all family violence incidents involving current or former intimate partners.

The ACT Government is committed to preventing and responding to domestic, family and sexual violence in the ACT community. A full picture of investment in 2024-25 to address domestic and family violence can be found in Appendix H of the Budget Outlook, within the 2024-25 Budget Papers. In total, the 2024-25 Budget provided \$12.246 million in new investment towards domestic, family and sexual violence initiatives over 4 years, including a significant funding boost for frontline services. As part of its commitment to addressing domestic and family violence, the ACT Government is developing a comprehensive, evidence-based ACT Strategy to provide a whole of Government, whole of community approach to preventing and responding to domestic, family and sexual violence over the next 10 years, to be developed in consultation with stakeholders.
