RESPONSE TO QUESTION ON NOTICE Questions on Notice Paper No 5 Friday, 11 April 2025 Question No. 332

SHANE RATTENBURY MLA: To ask the Minister for Tourism and Trade

- 1. What were the top country sources of new foreign direct investment in the ACT in 2023-24 by dollar value.
- 2. How does the ACT Government engage with existing foreign investors in the ACT and facilitate their growth. Is there a strategic relationship management approach for the largest existing investors.
- 3. Can the Minister share information which may have been provided to the Minister by Austrade of all the existing foreign investors in the ACT, and the dollar value of their investment.
- 4. Can the Minister provide a list of projects facilitated by the ACT Government's engagement with foreign investors, the precise nature of that inward investment assistance, the value of that foreign investment, and how many jobs it supported.
- 5. How is the Minister measuring the success of the Office for International Engagement's engagements with incoming delegations, noting that there were more than 50 delegations
- 6. Can the Minister list some of the commercial or cultural outcomes, ensuring these are specific.

ANDREW BARR MLA - The answer to the Member's question is as follows:

- 1. There is no data available on foreign direct investment that is disaggregated to the state and territory level.
- 2. Contact from potential foreign investors can occur across government. Economic Development, within the Chief Minister, Treasury and Economic Development Directorate, provides an Investment Concierge Service to work with investors and coordinate across government where necessary. It is a free, personalised service to support potential investors and provides one-on-one guidance at every stage of the investment journey, with the most common activity being requests for information and connections with relevant government agencies.

The concierge service works with the Australian Government through Austrade to maximise inward investment by promoting ACT capability and providing tailored responses to prospective investors. All information about the service is available on www.canberra.com.au.

In addition, the ACT Government funds the Defence and Advanced Technology Industry Advocate who supports both ACT and multinationals and the Canberra Innovation Network which provides a range of programs including investor showcases and First Wednesday Connect.

- 3. Austrade connects state and territory governments with prospective investment opportunities from time to time. These connections are typically made at the government official level and are done on a confidential basis.
- 4. The answer to Question two outlines the type of activities the ACT Government undertakes when it is dealing with investors, whether they be foreign or domestic investors. Typically, any proactive targeting of investors focusses on broad opportunities rather than specific projects. As such, it is difficult to draw specific links between these engagements and any final decision made by a foreign investor to invest in Canberra, which can often be years after assistance is provided. Also relevant is that foreign investment may trigger assessment under Australia's foreign investment framework which adds to the complexity of providing advice about specific projects.
- 5. Of the 50 activities referenced, not all were inbound delegations. Some were Trade Missions, educational activities, as well as events and workshops. The Office of International Engagement often facilitates meetings between inbound delegations and ACT Government officials to discuss ACT Government strategic policy, governance and their implementation. Meetings are also arranged with Canberra firms, but outcomes are not necessarily advised, as the nature of these discussions are sensitive and commercial in confidence.
- 6. There were 31 inbound delegations that year (2023-24), a summary of which can be found Attachment A.
