Council Name	Frequency of Meetings
ACT Health System Council*	The Council meets at least quarterly each year but no more than six times.
Canberra Region Medical Education Council (CRMEC)	There are four Council meetings per year, multiple sub-committee meetings (accreditation committee and education committee each of which meet four times/year) and out-of-session meetings as required by business arising.
Gene Technology Advisory Council (GTAC)	GTAC does not have a set schedule and meets at the discretion of the Minister or the Chief Health Officer. GTAC regularly provides advice out-of-session on Office of Gene Technology Regulator (OGTR) Licence Applications circulated for consultation.

Council Name	Frequency of Meetings
Non-government Organisation Leadership Group (NGOLG)*	NGOLG has previously met approximately four times a year, with meeting frequency dependent on need and other demands on members' time. The NGOLG was established in 2019 and during the COVID-19 pandemic met more frequently.
Restricted Medical Treatment Assessment Board	The Board meets four times per year. Committees of the Board meet more frequently to assess applications for Restricted Treatment, as they are received.
Union and Professional Associations Forum (UPAF)	UPAF normally meets quarterly, although the meeting rhythm has been interrupted by the caretaker period and Machinery of Government activity.
