## RESPONSE TO QUESTION ON NOTICE Questions on Notice Paper No. 41 12 April 2024 Question No. 1775

**MS LEE**: To ask the Deputy Chief Minister —In relation to QON 1697:

- (1) Can the Deputy Chief Minister provide for each complaint, or any other mechanism of referral, in relation to fraud and misconduct to the Community Services Directorate the length of time between the Directorate being made aware of these allegations and the allegations being closed between 2016 and present, including if the complaint has been referred internally or externally.
- (2) If the case is still open can the Deputy Chief Minister provide details of (a) when the allegation was received by the Directorate and (b) how many days the allegation has been investigated either internally or externally.
- (3) Can the Deputy Chief Minister provide the same information as parts (1) and (2) for each bullying and harassment allegation made to CSD between 2016 and present.

MINISTER BERRY: The answer to the Member's question is as follows —

(1) Partial information for question 1 has been provided in the table below. This includes information on the fraud matters only. As Ms Lee has requested information on all misconduct matters, this would be a significant administrative burden and would require every misconduct matter identified in QON 1697 to be manually reviewed. QON 1697 cost the Directorate >\$5,000 to answer, and this response would be similar in cost and is considered an inappropriate diversion of resources.


