**DEBORAH MORRIS MLA:** To ask the Minister for Police, Fire and Emergency Services — In relation to the answer to question taken on notice No 17 of the Standing Committee on Legal Affairs' inquiry into Annual and Financial Reports 2023-2024, can the Minister provide an updated version of the table of the number of apprehensions involving breach of bail and a breakdown of the offences for which individuals were arrested to cover the full 2024–25 reporting period.

**DR MARISA PATERSON MLA** - The answer to the Member's question is as follows:

The table below shows the number of offenders apprehended who are believed by police to have breached their respective bail condition(s) and, in addition, the number of offenders apprehended for other offences and who were, at that time also on bail. Note, an offender can be apprehended more than once during the reference period.
