RESPONSE TO QUESTION ON NOTICE Questions on Notice Paper No 39 9 February 2024 Question No. 1588

MS LEE MLA: To ask the Minister for Housing and Suburban Development:

- (1) How many houses, townhouses and units did Housing ACT own, as at 30 June 2023.
- (2) How many houses, townhouses and units did Housing ACT own, as at 30 June 2012.
- (3) Can the minister detail cash capital inflows for all Housing ACT real estate assets sold, including assets where the cash receipts were recognised somewhere else in the ACT Government other than the Housing ACT financials, for the years (a) 2011-12 to 2022-23 and (b) 2023-24 to 31 December 2023.
- (4) Can the minister detail cash capital outflows for all Housing ACT real estate assets purchased, built or developed, including payments made to the Suburban Land Agency for land, for the years (a) 2011-12 to 2022-23 and (b) 2023-24 to 31 December 2023.

MINISTER BERRY MLA - The answer to the Member's question is as follows:

- 1) Housing ACT owned 5906 houses, 1411 townhouses and 4295 units (including older persons accommodation) as at 30 June 2023.
- 2) Housing ACT owned 6385 houses, 1072 townhouses and 4391 units (including older persons accommodation) as at 30 June 2012.
