



LIST OF OUTSTANDING WORKS:

- This Operational Acceptance Certificate is issued without the acceptance of WAE by Asset Integration Unit. Consultant/Developer to provide additional information for compliance if required
- 2. Clearance of Bollards from edge of the path: Does not comply with TCCS Standards. Developer RAM to monitor the safety and move to grass area if required. Any relocation of the bollards will be at TCCS discretion and if required, the relocations must be completed prior to Final Acceptance.
- 3. Keys to be handed over (BBQ and distribution box) to TCCS. Irrigation box keys to be retained by SLA for the next 6 months until handover to TCCS
- 4. Playground equipment's defects are to be completed on or before 18/11/2022.
- 5. These defects are minor on-site for ceremonial opening. However all these defects are to be rectified to the satisfaction of TCCS before opening to the public.





ATTACHMENT B

CONDITIONS FOR FINAL ACCEPTANCE

Note that the issue of a *Certificate of Final Acceptance* at the completion of the defects liability period requires the following:

- 1. Satisfactory submission of WAE Drawings and test certificates which were not included in the *Certificate of Operational Acceptance* or for any rectification works carried out during the defects liability period.
- 2. Certification and evidence by the Consultant that the sub soil drainage systems (SSDS) were regularly monitored and satisfactorily maintained during the defects liability period and are in good working order.
- 3. Certification and evidence by the Consultant that all the backfilled trenches were regularly monitored for any settlement or defects and made good if necessary during the defects liability period.
- 4. All Outstanding Works listed in Attachment A are completed to the satisfaction of Asset Acceptance.
