- 1. How much money annually does the ACT Government provide to the Canberra Innovation Network (CBRIN).
- 2. What in-kind contribution does the ACT provide to CBRIN each year.
- 3. What proportion of CBRIN's annual revenue comes from the ACT Government, including in-kind contributions.
- 4. Can the Minister provide details, for the last four financial years and 2024-25 to the end of February 2025, on these related party transactions, including the nature of the transaction, dollar figure, and the relationship of these entities and individuals to key management personnel.
- 5. What are the total remuneration packages of the CBRIN's Chief Executive Officer and General Manager Growth Programs.
