1. How many licences over unleased Territory land are in place.
2. Can the Minister provide a list of the blocks of land that are covered by those licences referred to in part (1)
3. How many of the blocks, referred to in part (2), are subject to an Environmental Authorisation.

Ms Tara Cheyne MLA – The answer to the Member's questions are as follows:

1. Transport Canberra and City Services currently administers 87 licences issued pursuant to the Planning Act 2023 - Section 378 (Decision on licence applications for unleased land).
2. A list of current public land licence locations (block/section) issued under the Planning Act 2023 is provided at [Attachment A](#).
3. In accordance with the Planning Act 2023, prior to approval, all licence applications must be approved by the Conservator of Flora and Fauna's Office.
